AFFIDAVIT AND REQUEST FOR ARREST WARRANT PURSUANT TO M.R.Crim. P. 4

TO: Any Judge of the District Court or Justice of the Peace:

I, <u>Detective Lawrence M. Anderson</u>, a law enforcement officer for the Maine State Police Washington County, State of Maine, being duly sworn, depose and say:

The facts and circumstances, which lead your affiant to believe this, are as follows:

- 1. Your Affiant is a Detective with the Maine State Police, Major Crimes Unit North. Your Affiant has been a Detective since January 2016. Before this your affiant was a Trooper with the Maine State Police since May of 2007. Before this your affiant was a Police Officer with the City of Waterville since January of 2003. Your Affiant possesses a Bachelor of Science Degree in Law Enforcement from Western New England University. Your Affiant has successfully completed the Maine Basic Law Enforcement Training Program (BLETP), which was conducted at the Maine Criminal Justice Academy in Vassalboro, Maine. Your affiant has completed the State Police Recruit Training Program in addition to the BLETP. Your Affiant has also investigated numerous serious crimes, including but not limited to Murder, Sexual Assault, Burglary, Felony Theft, Domestic Violence, Death Scenes and Child Abuse, during your affiant's career as a law enforcement officer. Your affiant's involvement has included the preparation and execution of search warrants, the interviewing of suspects and witnesses, and the arrest of persons charged with the above listed crimes.
- On April 21, 2022 at 845PM, Sgt Greg Mitchell called your affiant and requested that he
  respond to 27 Thunder Road in Pleasant Point to help Pleasant Point police investigate a
  suspicious death.
- 3. Upon arrival, your affiant made contact with Detective Corporal Jason Fowler and Pleasant Point Officer Pete Harris. Detective Fowler told your affiant that at on April 21, 2022 at 8PM, Sam Neptune went to check on his sister, Kimberly Neptune, at 27 Thunder Road in Pleasant Point, Apt 63. Kimberly Neptune lives alone at this apartment. Sam had his own key to Kimberly's apartment, and he used it to unlock Kimberly's door. Once inside, Sam located Kimberly's lifeless body on the floor of her bedroom, wrapped in

what appeared to be a blanket. Sam unwrapped Kimberly and discovered she was bloody and had no pulse. Sam exited Kimberly's apartment and flagged down Pleasant Point Police Officer Matthew Cummings, who happened to be driving by the residence.

- Pleasant Point Police Officer Matthew Cummings and Sam reentered Kimberly's residence together. After examining the scene, Officer Cummings backed out and contacted the State Police for assistance.
- 5. On April 21, 2022 at 1043PM, Detective Corporal Fowler, Pleasant Point Officer Peter Harris and your affiant entered Kimberley's apartment. Your affiant observed a set of bloody footprints on the stairwell leading to the second floor. Your affiant further observed Kimberly's lifeless body lying on the bedroom floor, between a bed and a dresser. Your affiant noticed there were blood-stained pillows and blankets on the bed, and the clothes Kimberly was wearing appeared to be saturated with blood. A closer examination of Kimberly's body revealed she had multiple stab wounds on her legs, stomach, neck, and head.
- On April 22, 2022 at approximately 1215AM, Detective Corporal Fowler placed
  Kimberly's body in a body bag, and she was removed from her residence and transported
  to the Medical Examiner's Office in Augusta.
- 7. On April 22, 2022, the Maine State Police Evidence Response Team (ERT) was contacted and responded to the scene.
- 8. On April 22, 2022 at 930AM an autopsy was conducted on Kimberly's body by Dr. Liam Funte at the Medical Examiner's Office in Augusta. Dr. Funte ruled Kimberly's death a homicide and the cause of death was determined to be multiple sharp forced injuries. Dr. Funte located 484 stab or incised wounds on her body.
- 9. On April 22, 20022 your affiant spoke to Det. Scott Duff. Det. Duff had conducted an interview with Hailie Levesque (DOB 4/4/03) on 4/22/22 at 2136 hours. During this interview with Hailie, Det. Duff learned that Hailie had overheard Kailie Brackett talking inside the Perry Farmer's Union store on either 4/19/22 or 4/20/22. Hailie reported that she had heard Brackett state that, "Kim is going to pay for stealing that money." Hailie stated that Brackett had made this comment to several people. Hailie stated that Shelly Arsenault was working at the store as a clerk and was present for these remarks as well. Hailie stated her husband, Muwinesis Levesque (DOB 9/16/97) was also present.
- 10. On April 28, 2022 at 609PM your affiant spoke to Muwinesis Levesque on the phone. Muwinesis recalled being with his wife Hailie at the Perry Farmer's Union store recently, when Kailie talked about Kim stealing money. Muwinesis recalled hearing Brackett say she was missing money and she suspected Kim had stolen from her. Muwinesis recalled hearing Brackett say Kim was going to regret it. Brackett was talking to anyone who would listen to her. Muwinesis thought Brackett was cashing out as she was saying these things, but he couldn't recall who the cashier was.

11. On April 25, 2022 Detective Chad Lindsey interviewed Ambrose Bassett. Ambrose stated he had created the picture collage of four photos that was going around Facebook. The top two photos Bassett took from Kailie Brackett's Facebook page and depict her wearing a mask that is consistent with the mask seen in the bottom two photos which are still-frame images taken from the video system of Kimberly Neptune's next-door neighbor of a suspect in the homicide. Below is the group of photos referenced by Bassett.

- 12. On April 28, 2022, your affiant learned the following information from Det. Dana Austin. On April 23, 2022 Melissa Dana (DOB 2-3-1985) approached Det. Austin and told him that she had seen the videos on Facebook, and she recognized the woman in one of the video clips as Kailie Brackett. Melissa recalled seeing Kailie Brackett passing out flyers on April 18, 2022 and she was wearing the same clothes that the woman was wearing in the video.
- 13. On April 28, 2022, Det. Austin conducted a follow-up interview with Melissa Dana. Your affiant learned from Det. Austin that Melissa Dana was 100 percent sure the person in the Facebook video was Kailie Brackett. Melissa Dana said Kailie was wearing the same clothes in the video as she was when she saw her handing out flyers. Melissa Dana said she has known Kailie Brackett her whole life and knows what she looks like.
- 14. On April 28, 2022, your affiant learned the following information from Det. Dana Austin. On April 27, 2022, Det. Dana Austin and Det. Chad Lindsey conducted two interviews with Donnell Dana (DOB 5-8-1983). During the first interview Donnell agreed to talk at the Pleasant Point Police Department. Donnell stated the following: He has violent seizures and nonviolent seizures, and he took three different medications for the seizures. Donnell stated Kailie Brackett was the love of his life, however they were not a couple. Donnell stated he and Kailie have a son together. Donnell recalled he lived with Kim for a couple of years, and he moved out in the Summer or Fall of 2021. Donnell was unsure if he and Kim were ever in a romantic relationship. Donnell recalled when he lived with Kim, he would sleep on her couch. Donnell recalled Kim sold Xanax, and he had bought them from her before. Donnell recalled Kim would lock her doors after dark. Donnell recalled he had a key to Kim's apartment; however, he gave it back. Donnell couldn't recall if he owed Kim any money. Donnell knew Kim bought a camera when he lived with her.

Donnell recalled he was wasted one night when he lived with Kim and he blacked out and he climbed up the apartment stair divider and entered the apartment through a second story window. Donnell recalled Kim was really pissed at him because he knocked her camera off.

Donnell didn't know what happened to Kim, and he wished he knew who killed her. Donnell stated his blood and semen shouldn't be in Kim's house however, he thought he could have bled in Kim's house when he lived there. Donnell recalled Kim was very clean and she would clean her house every day.

Donnell recalled on April 20th, 2022 he thought he was at the hospital, and his family could vouch for that. Donnell then changed his mind and stated he could have been at his mom's house. Donnell stated his head was foggy. On the night of April 20th into April 21th, 2022 Donnell recalled being at his mother's house at some point and he recalled his son being there. Donnell's son told him he was lying on the floor twitching, and there was blood coming out of his mouth. Donnell stated he was either at Kim's or his mom's or maybe both, he didn't know.

Donnell wasn't sure when he was last at Kim's apartment. Donnell recalled he last stayed one night at Kim's in December of 2021.

When told his blood had been identified in Kim's apartment on Kim's stairwell, Donnell said he didn't know how his blood got in Kim's stairwell. Donnell was told there was a sex kit done on Kim, and he was asked if his semen would be in it when the results came back. Donnell stated, "I can't tell you either or". Donnell was asked if he knew whether or not he killed Kim. Donnell stated, he didn't kill Kim. He then told Det. Austin and Det. Lindsey to "fuck off" and to "go fuck yourselves". Donnell became agitated. Donnell then ended the interview and punched the wall as he left the interview room.

15. On April 28, 2022, your affiant learned the following information from Det. Dana Austin. On April 27, 2022, Donnell Dana showed up at the Pleasant Point Police Station with a female and wanted to talk. Det. Austin and Det. Lindsey talked with him. Donnell stated his mother and niece could youch for him that he was home the night that Kim died. Donnell stated he didn't remember it, however his mother and niece did. Donnell stated he was not a violent man unless provoked. Donnell stated he was not a murderer or a woman beater. Donnell stated he couldn't remember much about the 20th of April into the 21s of April 2022, but to his recollection he was at his mom's the entire night. Donnell said Kailie Brackett dropped off their son, Kevin, at his mom's house. Donnell stated his brain was "fried". Donnell stated he has bled at Kim's before. Donnell recalled he showed up at Kim's place one time with a broken jaw, and he had a hematoma. Donnell recalled that happened a year ago. Donnell stated he didn't know if Kailie knew what happened to Kim, Donnell stated he wanted to be behind Kailie because he loved her. Donnell stated he has never known Kaille to be violent. Donnell agreed to let the detectives check his body for any scrapes or marks. Detectives discovered Donnell had three linear marks on the upper part of his chest consistent with finger scratches, Donnell

also had marks on his lower legs and also one on his right ear. Donnell let Det. Lindsey take photos of the marks. Donnell said he had feelings for Kim but not in a sexual way. Donnell thought Kim was more into females. Donnell apologized for how he acted earlier. Donnell recalled he asked his mom to tell him if she thought he did it and she said he was there all night.

16. On April 28, 2022, your affiant learned from Det. Dana Austin that he and Det. Adam Bell had interviewed Krysti Longfellow (DOB 5-27-1993). During the interview, Longfellow stated the following: She saw Brackett at the Post Office last Friday, Brackett told Longfellow that Kim had just gotten 300 Xanax, and she had a couple thousand dollars on her. Donnell Dana and Brackett went to Kim's to rob her. Brackett told Longfellow that it was supposed to be a normal robbery, it was planned, and no one was supposed to get hurt. Longfellow said Brackett was supposed to meet up with Kim because they were "seeing each other". Brackett texted Kim that she was coming over to chill with her (Kim) for the night because she had a babysitter. Brackett told Longfellow that Kim said she hadn't shaved, so Kim told Brackett to let her get ready first. Brackett went over to Kim's at 1055PM on 20 April 2022 with "Skin". Your affiant knows that Donnell Dana (DOB: 5/8/83) goes by the nickname, "Skin." Brackett told her Kim opened the door for Brackett and Dana Donnell, ("Skin") was right behind her. Kim said she didn't want Dana there. Dana attacked Kim and dragged her up the stairs. Brackett told Longfellow that while Dana was attacking Kim, she (Brackett) grabbed 300 Xanax, iewelry, money, and other items. Bracket told Longfellow that Dana had a club, Brackett told Longfellow that Dana beat Kim's face in. Brackett told Longfellow that Kim put up a good fight. Brackett told Longfellow that she stabbed Kim five times. Brackett told Longfellow that she went for Kim's main organs. Brackett also told Longfellow that she stabbed Kim after she was dead. Brackett told Longfellow they tried to clean up the scene, but they were "fucked up" on Xanax, Subutex, and alcohol.

Brackett told Longfellow that she and Dana took bloody clothes, the club, and other evidence from the scene. Brackett told her that Dana got rid of the evidence down at Spring Water.

Brackett told Longfellow that she has all the passwords to Kim's Facebook, email, and her cameras. Brackett told Longfellow that she deleted everything from Kim's accounts, including her camera.

- 17. Brackett told Detectives that she dropped off her son at Dana's mother's house on the night of the crime. Your affiant knows, from autopsy photos, that Kim's pubic hairs had been recently shaved and/or groomed.
- 18. On April 28, 2022, your affiant learned from Det. Dana Austin that Donnell Dana and Kristi Longfellow bumped into each other in the evening hours of April 27th, 2022, on the tracks behind Longfellow's apartment. This is an area frequented by pedestrians and ATVs. Longfellow and Dana had a conversation near the tracks. This conversation happened after Dana was informed during a police interview that his DNA had been located at Kimberly Neptune's home. During the conversation, Dana told Longfellow

that his blood matches the blood that was found on Kim. Dana told Longfellow that he lived with Kim for four years, but he was nervous because Detectives told him it was fresh blood, and he didn't know they could detect fresh blood. Dana told Longfellow they just needed to charge him, and he didn't know why he hadn't been arrested. Dana told Longfellow that he wants to be charged, he did it, and he wanted to get this over with. Dana told Longfellow that he didn't know if he might get away with it because the Detectives let him go. Longfellow asked Dana if he did it, and he replied "Yes, I did it".

Dana told Longfellow it was a planned drug robbery. Dana told Longfellow he and Kailie Brackett set Kim by making it sound like a "booty call" was happening with Kailie Brackett. Dana told Longfellow that he was jealous of the relationship that Kailie and Kim had. Dana told Longfellow that it was a fight that got out of control. Dana told Longfellow that he wanted a ten pack of Xanax bars. Dana told Longfellow that he beat Kim's face in with his fists. Longfellow stated Dana said he went overboard by accident. Dana said Kim was making some noises and there was blood everywhere. Longfellow stated they rolled Kim in a blanket because he didn't want to see Kim's body. Dana told Longfellow they stabbed Kim after she was dead. Dana said they checked Kim's pulse and that she was gone. Dana said that Kim died at two in the morning.

Dana told Longfellow that Kim's soul is haunting him and Kailie Brackett was an accomplice. Longfellow's fiancé, Stephen Leone, and her mother, Kateri Longfellow, were present when Donnell said this. Longfellow's mom told her to get away from Dana

- Based on the above, your affiant believes that probable cause exists, that Kailie A. Brackett (DOB 03/03/1984) has committed the crime of Murder, pursuant to 17-A M.R.S. § 201(1)(A and B).
- THEREFORE, your affiant requests that a warrant issue for the arrest of said Kailie A. Brackett (DOB 03/03/1984) for the crime of Murder, pursuant to 17-A M.R.S. § 201(1)(A and B).

I, Det. Lawrence M. Anderson, DEPOSE AND SWEAR, UPON INFORMATION AND BELIEF, THAT ALL OF THE INFORMATION CONTAINED WITHIN THIS SEARCH WARRANT AFFIDAVIT AND REQUEST, IS BOTH TRUTHFUL AND ACCURATE.
