AFFIDAVIT IN SUPPORT OF PROBABLE CAUSE

I, Detective Einar Mattson, being duly sworn, do depose and swear to the following:

I am employed as a detective with the Maine State Police, and am currently assigned to Major Crime Unit, Central Field Division. I am a sworn law enforcement officer and a graduate of Maine State Police Academy. I graduated from the Maine Criminal Justice Academy in November of 2019. I have investigated and/or participated in the investigation of suspicious deaths, child/infant deaths, and homicides.

My primary responsibilities as a detective with the Maine State Police are investigations of homicides, suspicious deaths, sexual assaults, and other serious crimes.

The following facts and circumstances have led this affiant to believe that JAMES CLARK, DOB: 04/06/1976, committed the crime of Intentional and Knowing Murder pursuant to Title 17-A M.R.S. §201 (1)(A) in the town of Waldoboro on or about August 7, 2025.

My Basis for Probable Cause is as Follows:

- 1. I am an Investigator assigned to the Maine State Police, Major Crimes Unit, investigating the homicide of LEVERN KELLEY: DOB: 09/25/1971. The homicide occurred on or about August 7, 2025, in the town of Waldoboro and was reported on August 9, 2025, to the Waldoboro Police Department (WPD). The Maine State Police (MSP) Major Crimes Unit-Central (MCU-C) was requested to assist with the investigation.
- 2. On August 9, 2025, at approximately 8:25 AM, WPD was dispatched to 506 Genthner Road in Waldoboro for a report of a deceased female on the front porch of the residence at that address. The female later identified as LEVERN KELLEY was located by a co-worker, HEATHER AIKEN. HEATHER had gone to LEVERN'S home after learning that LEVERN had not reported to work as scheduled that morning. HEATHER and her boyfriend TRISTEN RANDALL drove to LEVERN'S home. TRISTEN remained in the vehicle and HEATHER walked to the house. Upon approaching the front door, HEATHER observed that the front door was open. When HEATHER got to the top of the porch steps, she saw LEVERN'S body lying face down on the porch and what appeared to be a large

amount of blood. HEATHER returned to her vehicle without touching anything and she and TRISTEN retreated to the end of LEVERN'S driveway to call 911.

- 3. Officer Brian Collamore, WPD responded. Off. Collamore entered the residence and outbuildings to confirm there were no other victims and no one else was present on the property. Off. Collamore also took initial photographs of the scene. I reviewed Off. Collamore's photographs and they are consistent with the scene described by HEATHER. In addition, Off. Collamore noted expended shell casings on the porch near LEVERN'S body as well as what appeared to be footwear impressions in blood near the body. Off. Collamore observed and photographed HEATHER and TRISTEN'S shoes and did not observe any evidence of blood or a similarity to the impressions on the porch.
- 4. I arrived at 506 Genthner Road and spoke with Lt. Michael Murphy, Lincoln County Sherrif's Office (LSO). I learned from Lt. Murphy that the last person known to have spoken with LEVERN was BETH ROSCOE. This was a phone conversation which occurred on Thursday, August 7, 2025, at approximately 6:00 PM. I also learned that LEVERN'S sister, MARION YAGER and LEVERN'S exhusband ROBERT KELLEY had come to the scene. Both MARION and ROBERT had been notified about LEVERN not coming to work that morning and had come to check on LEVERN.
- 5. I also spoke with Det. Justin Drake. Det. Drake is an LSO Deputy. Det. Drake conducted an interview with HEATHER. I learned from Det. Drake that HEATHER received a text message from her supervisor at Pen Bay Laboratories (PBL) where both HEATHER and LEVERN work. It was generally known among LEVERN'S coworkers that LEVERN was involved with JAMES CLARK. It was also generally known that the relationship was abusive and that LEVERN had told coworkers that if she (LEVERN) didn't show up for work, it was because she was dead and that JAMES killed her. While LEVERN was employed at PBL, she had been married to JAMES. They divorced, but HEATHER and other coworkers were aware that LEVERN had recently started seeing JAMES again. I also learned from Det. Drake that JAMES was arrested for a Domestic Violence (DV) assault against LEVERN in May of 2024.
- 6. Det. Nick Watson, MSP, conducted a follow-up interview with HEATHER. I learned from Det. Watson that HEATHER confirmed LEVERN'S coworkers were immediately worried that LEVERN did not come to work and that LEVERN was a reliable employee who did not miss work without notifying a supervisor. HEATHER showed Det. Watson the text message she received that morning from TABITHA MARKS (HEATHER and LEVERN'S supervisor). The message stated:

LEVERN didn't show up for work today. We have it covered. But I tried calling but she didn't answer. Mikayla has tried messaging her too. I'm just worried given what we know

This message is what prompted Heather to check on LEVERN.

7. Det. Watson also interviewed MARIAN YAGER, LEVERN'S sister. I learned from Det. Watson that JAMES did not own any vehicles and would drive vehicles registered to LEVERN or to PAULINE BREWER, JAMES' mother. MARIAN described instances of abusive behavior she had heard about from LEVERN. These included an instance where JAMES had held a gun to LEVERN'S head and threatened to shoot LEVERN. MARIAN said that LEVERN told her this was witnessed by JAMES' mother PAULINE. MARIAN noticed a recent behavior change in LEVERN around July 4, 2025 when LEVERN became more withdrawn and evasive. MARIAN believes that this is when LEVERN began

seeing JAMES again. MARIAN had never witnessed any violence by JAMES towards LEVERN but had seen bruises on LEVERN'S arms and legs.

- 8. Det. Watson interviewed MARIAN'S husband MARK YAGER who had also seen LEVERN with bruises. MARK had also been told about JAMES threatening LEVERN with a gun and believed that this occurred in 2023.
- 9. Det. Watson interviewed LEVERN'S ex-husband ROBERT KELLEY. ROBERT was married to LEVERN from 2016-2021 and they had an amicable relationship following their divorce. ROBERT suspects the LEVERN had purchased firearms for JAMES because JAMES could not legally purchase or possess a firearm
- 10. Det. Casey McDonald, MSP, interviewed BETH. I learned from Det. McDonald that BETH last saw LEVERN when LEVERN left work at 2:30 PM on August 7, 2025. BETH spoke with LEVERN starting at 6:01 PM on that day and among other things LEVERN told BETH that she had seen JAMES at JAMES' mother's house after work that day and that LEVERN and JAMES had argued over financial issues. While BETH was on the phone with LEVERN, LEVERN told BETH that JAMES had arrived at her (LEVERN'S) home. LEVERN told BETH that she (LEVERN) would call back and ended the call. BETH had no further contact with LEVERN after that call. BETH considered herself to be a confidant to LEVERN and disclosed several things she had learned from LEVERN to include:
 - a. LEVERN and JAMES had started seeing each other again in early July of 2025.
 - b. LEVERN was hiding the relationship from her family because LEVERN'S family did not like or approve of LEVERN seeing JAMES.
 - c. LEVERN told BETH that JAMES had threatened to kill her (LEVERN) in the past.
 - d. JAMES was still angry at LEVERN about his arrest on DV Assault charges.
- 11. Det. McDonald also interviewed KRISTINE ALBERS, KRISTINE is a coworker of LEVERN. KRISTINE was trained by LEVERN and considered herself to be a close friend. KRISTINE saw LEVERN communicate with JAMES while at work, usually over text message. KRISTINE also saw that these conversations would often upset LEVERN. KRISTINE told Det. McDonald that anytime she saw LEVERN upset and using her phone it was because LEVERN was communicating with JAMES. KRISTINE heard from LEVERN that JAMES had threatened LEVERN with a gun and during one incident fired a gun inside LEVERN'S home.
- 12. Det. Sgt. Jason Andrews interviewed LEVERN'S supervisor TABITHA MARKS. TABITHA is who started trying to locate LEVERN on August 9, 2025, after LEVERN did not report for work. TABITHA'S inquiry to HEATHER is what prompted HEATHER to go check on LEVERN. TABITHA had witnessed heated phone conversations between LEVERN and JAMES. These included instances where JAMES could be overheard yelling at LEVERN over the phone. TABITHA was concerned enough about LEVERN to have conversations with LEVERN about available Domestic Violence resources.

- 13. Sgt. Andrews interviewed PAULINE BREWER. I learned the following information from Sgt. Andrews: (This information was obtained over the course of multiple interviews of PAULINE by Sgt. Andrews)
 - a. JAMES lives with PAULINE at 101 Ledgewood Court in Damariscotta.
 - b. JAMES and LEVERN have a contentious relationship and LEVERN was not allowed inside that house if PAULINE was home.
 - c. When LEVERN was at the apartment, she and JAMES would socialize in the back yard area behind the building.
 - d. LEVERN was at the apartment on August 7, 2025 and left alone.
 - e. PAULINE said that JAMES left sometime "after dark" driving a silver Ford Focus with ME PC 987 JLD on August 7 and that JAMES has not been home since.
 - f. JAMES does not habitually stay out all night, PAULINE could not recall a time since JAMES has lived with her that he did not come home.
 - g. PAULINE has tried to contact JAMES, but his phone is not accepting calls.
 - h. JAMES is diabetic and is dependent on insulin. PAULINE noticed that JAMES' insulin is not in the refrigerator where it is stored but could not say how long it has been missing.
 - i. PAULINE has heard JAMES make threatening statements about LEVERN including words to the effect of: "I wanna see that bitch drop" and "She'll get hers".
 - j. JAMES does not have a job, credit card or receive State assistance.
 - k. During a follow up interview, PAULINE disclosed to Sgt. Andrews that she was in fact present and witnessed JAMES threaten LEVERN by placing a gun to LEVERN'S head.
 - 1. PAULINE denied seeing bruises or other injuries on LEVERN.
- 14. Sgt. Andrews interviewed ANGELIQUE DELANO. ANGELIQUE is also JAMES ex-wife. ANGELIQUE did not have any information regarding JAMES whereabouts. She did describe to Sgt. Andrews a highly abusive relationship. ANGELIQUE is in fear for her life because of JAMES' abuse and threats. ANGELIQUE relocated herself and her family while JAMES is unaccounted for.
- 15. I searched computer databases for information regarding JAMES. I learned that JAMES was the subject of an active arrest warrant in Maine for contempt. The warrant is not extraditable outside of Maine. I also learned that JAMES' license to operate a motor vehicle is revoked and that JAMES has no motor vehicles registered under his name.
- 16. I applied for and received a warrant to search 506 Genthner Road. Among other evidence, multiple expended shell casings were located in the area of LEVERN'S body. An unfired small caliber round of ammunition was also recovered. Swabs of Red/Brown stains consistent with blood were taken from an area near the steps on the porch where LERVERN'S body was located. The swabs were obtained from stains that were separate from the large stains surrounding LEVERN'S body. Due to the location and shape of the stains they did not appear to have originated from injuries to LEVERN.
- 17. The swabs were forwarded to the MSP Crime Laboratory. DNA Analyst Rachel Bell identified a single source male DNA profile. The DNA profile was technically reviewed and searched in CODIS. The search returned a match to the offender profile for JAMES CLARK.

- 18. LEVERN'S residence was neat and orderly. There was no sign of a struggle, and nothing appeared to have been taken. LEVERN'S phone was located inside the residence on the kitchen counter. LAVERN'S identification, credit cards and cash were also stored inside the phone case.
- 19. In addition to 506 Genthner Road, search warrants were applied for, granted and executed at 101 Ledgewood Court in Damariscotta (JAMES and PAULINES residence) and 255 Upper East Pond Road in Nobleboro (A storage unit leased by JAMES).
- 20. In JAMES' residence, ammunition was located that was of the same type as the ammunition and shell casings found with LEVERN'S body. Specifically, a 50-round box of "Aguilla" branded ammunition was collected. This box had five live rounds remaining. The ammunition in the box had the same "A" headstamp and solid lead bullet as the live round of ammunition found near LEVERN and the same headstamp as the shell casings recovered near LEVERN. (All of the projectiles later removed from LEVERN'S body at autopsy were solid lead .22 caliber bullets consistent with what was recovered both at the crime scene and at JAMES'S residence.). In addition to this matching ammunition, a variety of other ammunition was present.
- 21. In addition, manufacturers packaging (a box) was found for a Kel-Tec firearm. The box found was for a rifle and a different caliber of ammunition than what was located in Waldoboro.
- 22. Det. Watson attempted to locate and interview JEFF BURNHAM. JEFF is a friend of JAMES and may have information about JAMES' whereabouts. Det. Watson was unable to locate JEFF but did interview JEFF's girlfriend, DENISE ALONZO. DENISE confirmed that JEFF and JAMES were friends. DENISE had last heard from JEFF on August 7, 2025 when JEFF said he was going to meet JAMES. This was at approximately 9:00 PM.
- 23. Det. Watson later learned from DENISE that JEFF had been dropped off at Mt. Auburn Hospital in Cambridge, MA. JEFF had been there since Saturday. All JEFF would tell DENISE was that he was "ditched" in Massachusetts and that he no longer had his phone. JEFF wanted a ride back to Maine, but DENISE was unable or unwilling to pick him up.
- 24. Det. Watson confirmed that JEFF had been admitted to Mt. Auburn hospital and that JEFF was discharged at 9:45 AM on Sunday August 10, 2025. The hospital had no further information regarding JEFF'S whereabouts.
- 25. JEFF later contacted Det. Watson and confirmed that he was willing to be interviewed but was unable to return to Maine on his own. JEFF told Det. Watson that he had been with JAMES on August 7, 2025 when JAMES left Maine. JEFF also told Det. Watson that JAMES told him that he (JAMES) had to leave Maine because he (JAMES) had put a gun to LEVERN'S head and "nicked" her.

- 26. The Maine Information Analysis Center (MIAC) was contacted and a bulletin was issued on the Ford Focus that JAMES is believed to be operating. MIAC also requested available information from license plate readers (LPR) and other traffic monitoring systems.
- 27. MIAC received multiple reports of "hits" on a silver Ford Focus bearing ME PC 987 JLD plates. The first in Salisbury, MA on August 7, 2025 at 11:33 PM. There have been multiple other hits on the plates in Massachusetts, Connecticut, Maryland, Delaware, North Carolina and Georgia.
- 28. On August 11, 2025, Delaware State Police received a hit from their bulletin regarding the Ford JAMES is presumed to be operating. The hit was at a Quality Inn. Det. Strecker, Delaware State Police, went to the location and the vehicle was gone. Det. Strecker confirmed with the motel that no one using the name JAMES CLARK had checked into the establishment. An additional hit was received in Delaware at 8:00 AM from an LPR on August 11, 2025.
- 29. An autopsy was performed on LEVERN at the Office of the Chief Medical Examiner (OCME). The autopsy was performed by Dr. Liam Funte. Twelve small caliber projectiles (bullets) were removed from LEVERN'S body in addition to bullet fragments. The cause of death was determined to be multiple gunshot wounds, and the manner of death was determined to be homicide.
- 30. A search warrant was applied for and granted to perform an extraction on LEVERN'S phone. This is the phone recovered from LEVERN'S home after her death. The extraction was completed by Victoria Brennan a Cellular Forensic Analyst (CFA) at the MSP Computer Crimes Unit (CCU). A preliminary report was completed focusing on communications between LEVERN and JAMES for the time period of July 4, 2025-August 12, 2025. The following information was learned from that report:
 - a. LEVERN and JAMES communicated using text message over 1,700 times between July 4, and August 7.
 - b. LEVERN and JAMES communicated by voice call over 40 times during the same period.
 - c. On August 7, 2025 JAMES sent LEVERN text messages at 6:09 PM, 6:12 PM and 6:13 PM. LEVERN never viewed these messages.
 - d. After 6:13 PM on August 7, 2025, JAMES made no further attempts to contact LEVERN by voice or text.
- 31. In addition to the calls outlined above, CFA Brennan noted the final call placed on LEVERN'S phone was an outgoing call to BETH. This call was placed at 6:01 PM on August 7, 2025 and lasted for 30 minutes. The final unread text messages to LEVERN from JAMES were received during this call.
- 32. Det. Sgt. Ryan Brockway and I located JEFF BURNHAM at the Boston Medical Center in Boston. We met with JEFF at the hospital and transported him back to Maine after his discharge.

- 33. I explained to JEFF that he was not detained or the target of any investigation and that he was free to go at any time. I also explained to JEFF that we would return him to Maine regardless of his willingness to talk with us.
- 34. I learned the following information during my interview with JEFF:
 - a. JEFF and JAMES have been friends since childhood.
 - b. JEFF was aware of JAMES' violent history, particularly against women.
 - c. JEFF warned LEVERN against marrying JAMES. He said words to the effect of "it might be ok now but not when you do something he doesn't like"
 - d. JEFF described multiple other instances of violent behavior by JAMES to include an account of JAMES shooting him (JEFF) in the back with a shotgun loaded with bird shot. JEFF said that JAMES had intended to shoot another person with them, but he (JEFF) placed himself in the way because he was wearing a leather jacket that would protect him. JEFF did not believe JAMES' intent was to kill anyone due to the small gauge shotgun (.410) and the small shot size.
 - e. JEFF said that JAMES showed up at his apartment on August 7, 2025 around 9:00 PM. Jeff said that JAMES was highly agitated and that they had a physical altercation in the hallway. JEFF attributed this to JAMES having a sugar problem and said JAMES calmed down after JEFF gave him some candy.
 - f. JEFF gave an account of his trip with JAMES. JEFF was rambling and had difficulty staying on topic. Below is a summary of the trip as described by JEFF: *This is a summary it does not contain all of the information conveyed by JEFF during the interview.
 - 1) After the altercation at JEFF'S apartment and JAMES calmed down, they left in JAMES' car to go to Walmart. JEFF initially asked JAMES if he (JEFF) could drive due to JAMES' agitation, but JAMES refused. JEFF denied driving the vehicle at any point during the trip. When JEFF realized that they were not going to Walmart and questioned JAMES, JAMES told JEFF they were going to see his (JAMES') sister. When they continued to travel south, JEFF again questioned JAMES and at that point JAMES told JEFF that he (JAMES) had to leave because he had put a gun to LEVERN'S head and "nicked her". I pressed JEFF for more details, but JEFF denied knowing where this happened or what "nicked" might have meant. JEFF alleged that at this point he became afraid of JAMES and what he might do if he (JAMES) realized JEFF had become suspicious of JAMES. JEFF told me that JAMES' phone battery died somewhere in Maine and that JAMES smashed the phone against the dashboard. JEFF said they stopped in Massachusetts near the New Hampshire border. JEFF could not describe the store they stopped at in detail, but he said he went in and got snacks and more candy for JAMES. JEFF said he asked the employees for directions to Florida at JAMES' request. JEFF said that while JAMES was fiddling with the gas cap, he accidentally opened the trunk. JEFF described JAMES as rushing to close the trunk before JEFF could see what was inside. JEFF said that when he exited the store he saw JAMES outside the car with two "spikes". JEFF later described these as homemade weapons made from sharpening screwdrivers to a point. JEFF said he "knew from the look on his face" that JAMES was going to kill the store employees. JEFF said that he put his purchases on the ground and disarmed JAMES. JEFF said that he threw the weapons away and they left the store. JEFF said that he thought about running away but was afraid that JAMES would shoot him. JEFF

was insistent that JAMES had a gun but denied ever seeing one. JEFF insisted that JAMES was uncommunicative during the trip and did not confide in JEFF any details about what had happened. JEFF said the next time they stopped was in Boston and that JAMES left while JEFF was out of the vehicle.

- g. JEFF gave an account of his time in Boston and alleged that he lost his phone and wallet after he separated from JAMES. JEFF told me that the only thing of his in JAMES' car is a coffee cup with "Jeff" engraved on it.
- h. JEFF said that JAMES always carries a gun, sometimes multiple guns and believes that JAMES may have quickly closed the trunk of the car because he had guns in the trunk.
- i. JEFF was not surprised to hear that JAMES was suspected of killing LEVERN.
- 35. Based on the information above, your affiant believes that JAMES and LEVERN were together on August 7, 2025, and LEVERN was engaged in a conversation with BETH ROSCOE at 6:01 PM that day. LEVERN recounted an argument with JAMES earlier in the day and LEVERN told BETH that JAMES had just arrived at her home. The call lasted 30 minutes and LEVERN told BETH that she would call back and ended the call. This is the last known contact anyone had with LEVERN.
- 36. Your Affiant used Google Maps to calculate the time necessary to travel from 101 Ledgewood Court in Damariscotta (JAMES' residence) to 506 Genthner Road in Waldoboro (LEVERN'S residence). The drive time provided is sixteen minutes. The elapsed time between JAMES' final unread text message to LEVERN and the end of LEVERN'S phone call to BETH (when LEVERN tells BETH that JAMES is at her home) is eighteen minutes.
- 37. LEVERN'S phone extraction shows almost constant communication with JAMES until 6:13 PM on August 7, 2025. This is when the last text message from JAMES was received on LEVERN'S phone. JAMES does not attempt to contact LEVERN on her phone at any time after that.
- 38. Ater the final call with BETH ROSCOE, there is no further activity on LEVERN'S phone (placed or answered calls or sent/viewed text messages)
- 39. Blood was located near LEVERN'S body that, due to the location and shape of the droplets, did not appear to have originated from LEVERN'S injuries. Swabs were taken and tested at the MSP Crime Laboratory. A DNA profile was obtained that matched JAMES CLARK'S offender profile in the CODIS database.
- 40. Your affiant further believes that JAMES fled the State of MAINE on August 7, 2025, after killing LEVERN, in a vehicle registered to PAULINE BREWER. That vehicle has been seen on various cameras in Massachusetts, Connecticut, Delaware, Maryland, South Carolina and Georgia between August 7, 2025, and August 13, 2025.

- 41. JEFF BURNHAM accompanied JAMES as far as Boston after JAMES fled Maine. JAMES told JEFF that he had to leave the state because he "put a gun to LEVERN'S head and "nicked" her". JEFF was left in Massachusetts by JAMES. JEFF denies any knowledge of JAMES' movements after that.
- 42. JAMES is diabetic and dependent on insulin. JAMES took his insulin from his home showing he did not intend to return. PAULINE stated that this is the first time since JAMES has lived with her that he has not returned home overnight.
- 43. Your affiant believes that JAMES does not have access to financial resources, he brought JEFF BURNHAM with him when he left the state. Due to JEFF'S serious health issues, JAMES "ditched" JEFF at Mt. Auburn Hospital. JEFF was left without his phone or any resources to return to Maine. JEFF alleges that he lost his phone and wallet in Massachusetts and that JAMES does not have them. This has not been able to be verified by your affiant.
- 44. JEFF knows JAMES to carry a variety of firearms and said that JAMES "always" has a gun. JEFF denied seeing a firearm while he was travelling with JAMES, but JEFF expressed fear that if he angered JAMES then JAMES would shoot him.
- 45. JAMES has access to firearms and ammunition matching what was found near LEVERN'S body. This matching ammunition was located in JAMES' residence.
- 46. JAMES has an extensive criminal history including Domestic Violence charges against LEVERN. JAMES' other ex-wife ANGELIQUE DELANO also alleges violence against her committed by JAMES and is currently in fear for her life from JAMES.
- 47. Interviews with LEVERN'S associates and family did not reveal any other person who had reason to harm LEVERN. Furthermore, LEVERN'S coworkers had been told by LEVERN of JAMES' abusive behavior and LEVERN'S fear of JAMES.
- 48. This knowledge led TABITHA MARKS and HEATHER AIKEN to investigate HEATHER'S absence from work. HEATHER called 911 after discovering LEVERN'S body less than two hours after LEVERN did not report to work as scheduled.
- 49. PAULINE witnessed JAMES threaten LEVERN with a firearm by putting a gun to LEVERN'S head.
- 50. All of the above evidence and investigation, leads your Affiant to believe that JAMES has access to firearms. JAMES was in possession of ammunition that matches the ammunition used to kill LEVERN. JAMES has a history of violence against LEVERN and his previous wife ANGELIQUE. JAMES' behavior since August 7, 2025 has been out of character for him and your affiant believes he is actively trying to evade law enforcement.

- 51. Your affiant further believes that LEVERN had no other enemies, and no other information has been uncovered to indicate LEVERN was in danger from anyone other than JAMES CLARK. LEVERN was in sufficient fear of JAMES to communicate that with her coworkers.
- 52. Based on the investigation and the evidence described above your affiant believes that JAMES CLARK shot and killed LEVERN KELLEY on or about August 7, 2025, at her home in Waldoboro.
