DEFENDANT'S MOTION TO AMEND BAIL

NOW COMES Defendant, by and through undersigned counsel, and hereby moves this Court for the entry of an order amending Defendant's bail in the above-captioned matters to allow him to be released, and states as follows:

1. Following Defendant's most recent arrest for possession of pornography, Defendant was held without bail on all of the pending matters before the Court. These include probation violations for which Defendant has not had a hearing despite the statutory requirement that Defendant have a hearing within a set period of days.


2. Defendant's arrest arose out of his possession of pornography, not a new criminal event. While the conduct triggered Class E charges of violation of condition of release, those were only ancillary to the probation violations.

3. The State has sought to access Defendant's electronic devices, and there have been challenges in completing that work which are not the fault of the Defendant.

4. Defendant has been incarcerated since February 9, 2026. The next hearing date is likely not until May, at the earliest. Given the non-criminal nature of Defendant's conduct which gave rise to his arrest and incarceration, Defendant should be allowed to be released on reasonable bail pending final hearing in the above-captioned matters.

WHEREFORE, for the foregoing reasons, Defendant respectfully requests this Court enter an order amending Defendant's bail to allow for the setting of bail at a reasonable amount such that Defendant may be released pending hearing.
