AFFIDAVIT AND REQUEST FOR ARREST WARRANT

I, Jeremy Riddle, being duly sworn on oath depose and say that I am a law enforcement officer for the City of Sanford, County of York, State of Maine. I hereby request that a warrant of arrest be issued in the name of Lucas Lanigan, date of birth of 01/29/1979, for the offense of Domestic Violence Aggravated Assault, pursuant to Title 17-A M.R.S. Section 208-D.1.D a Class B offense. The basis for my probable cause is as follows:

1. On 10/25/2024 at approximately 1503 hours, Sanford Regional Communications Center received a call from [REDACTED]. She advised she was with [REDACTED] who had been strangled by her husband Lucas Lanigan. [REDACTED] advised they were located at 13 Grant St. in Springvale, ME.
2. During the course of my investigation, I learned the following:
 - a. [REDACTED] and Lucas Lanigan are married intimate partners who reside together at 13 Grant St in Springvale, ME.
 - b. [REDACTED] had finished a meeting at approximately 1230 hours. She then went to Springvale Safe Storage located at 282 River St. in Springvale, ME to meet with Lucas.
 - i. At approximately 1245 hours she arrived at the storage unit and saw Lucas was with a female named [REDACTED] and Lucas have been having an affair.
 - ii. [REDACTED] said she began yelling at [REDACTED] and confronting Lucas for the infidelity. She said Lucas then grabbed her around her neck with both hands and choked her for approximately 20 seconds.
 - iii. [REDACTED] was able to get away from Lucas and she went home and eventually called her friends.
 - c. [REDACTED] were contacted by [REDACTED] around 1415 hours. They said she was crying and said Lucas had choked her.
 - d. [REDACTED] and [REDACTED] then contacted [REDACTED] and [REDACTED]. All four females then went to [REDACTED] house and contacted the police.
 - e. [REDACTED] was transported to Maine Medical Center Sanford by EMS.
 - f. [REDACTED] has bruising on the left and right side of her neck. She also has petechiae on her face, nose, and inside her mouth.
 - g. [REDACTED] also had incontinence as a result of the strangulation.
 - h. I called Lucas' cell phone twice. His voicemail was full and he did not try to call back. His whereabouts are currently unknown.
 - i. Lucas is likely driving his work truck, a black Ford F-150 with SHE/LUX written in white lettering on the side.
